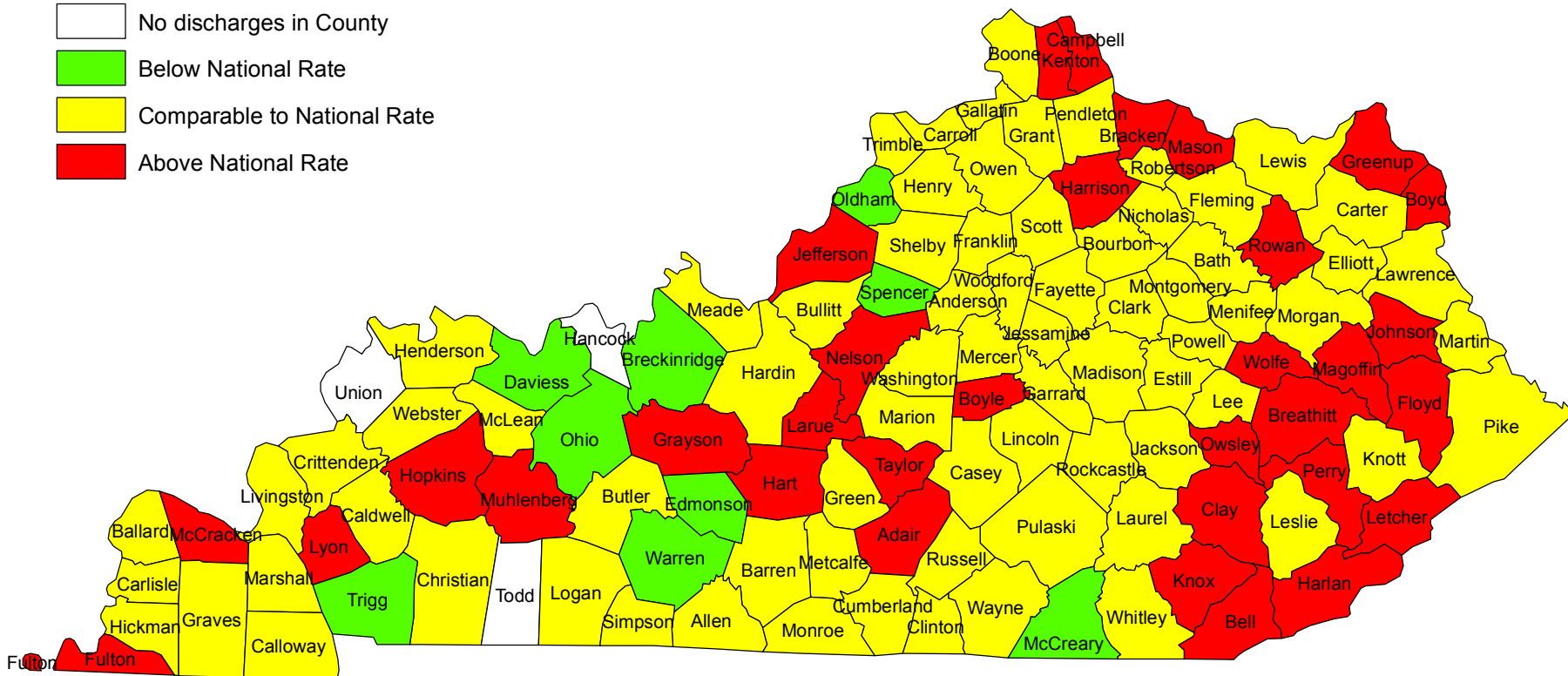
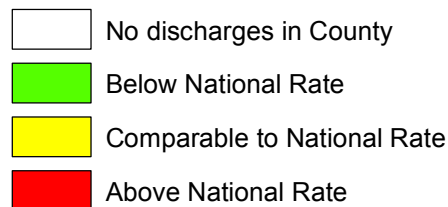


Diabetes Short-term Complications Admission Rate (PQI 1)

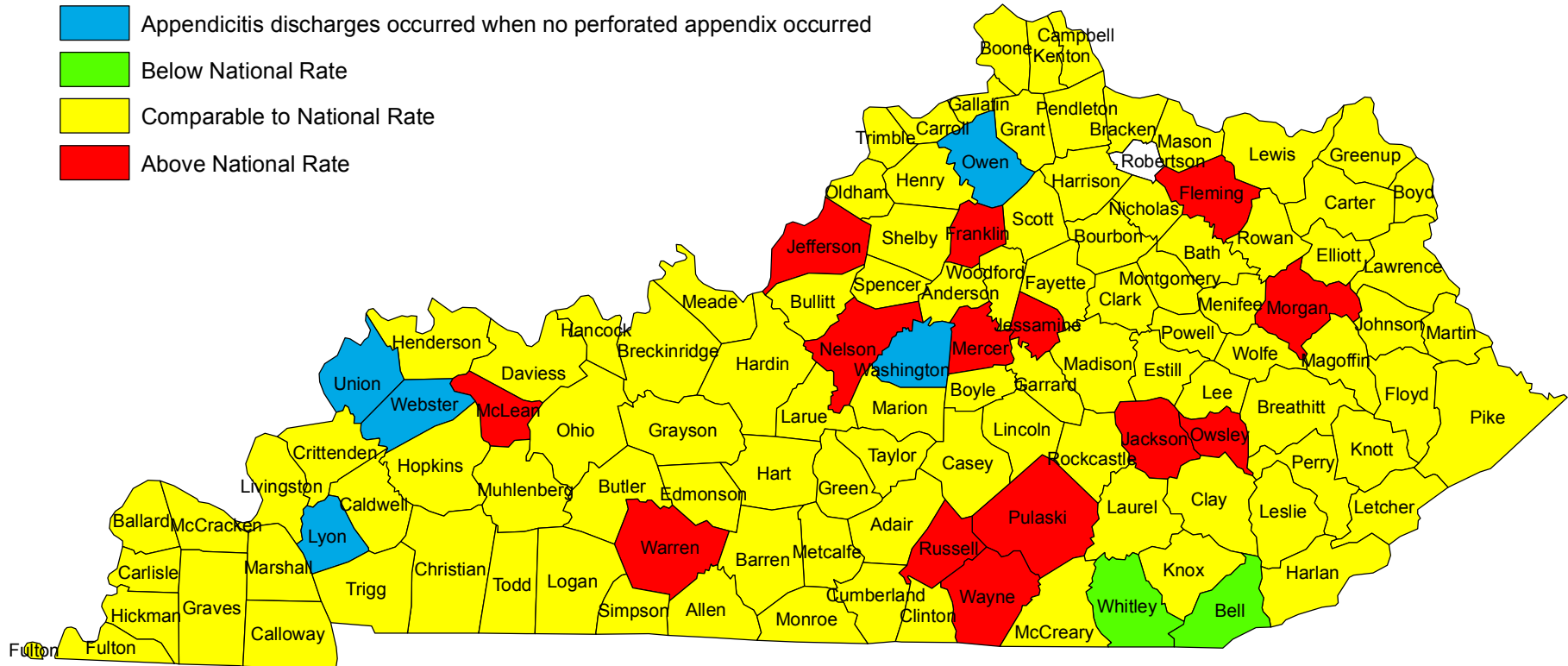

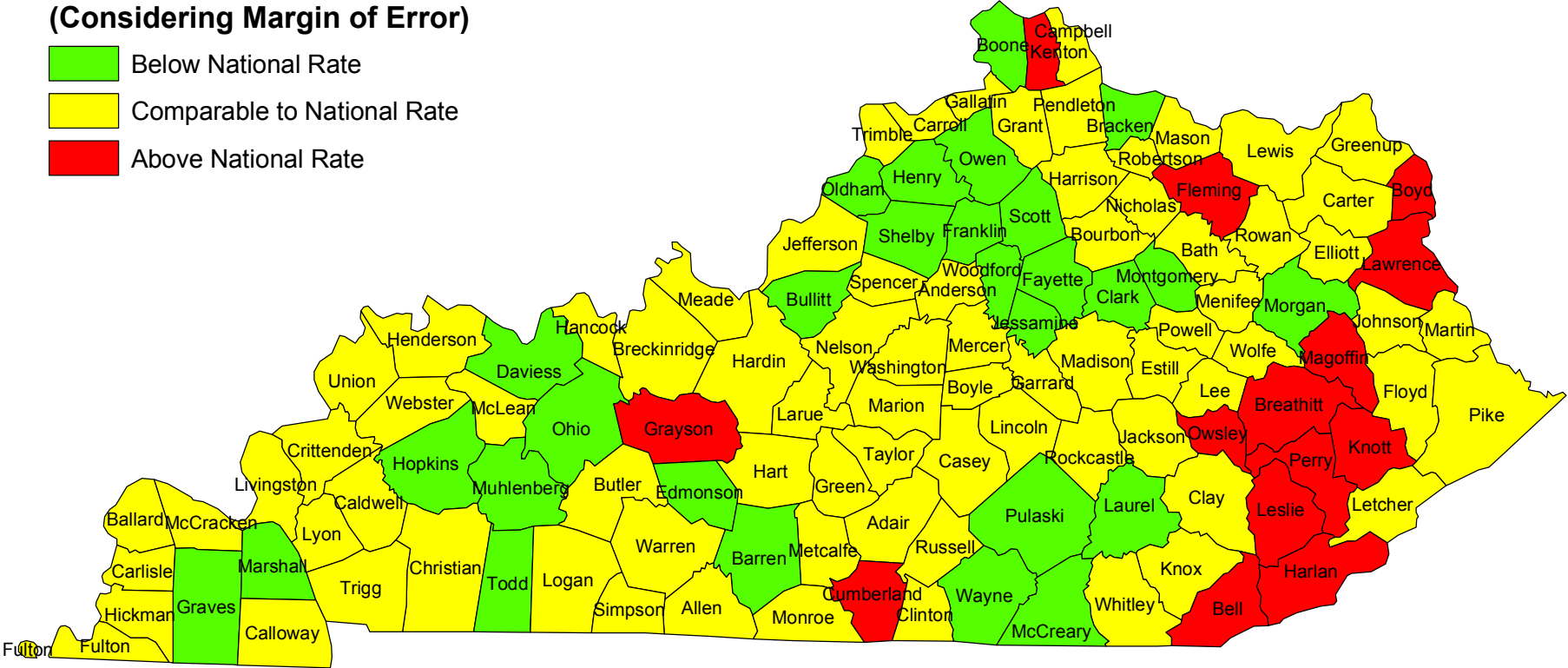

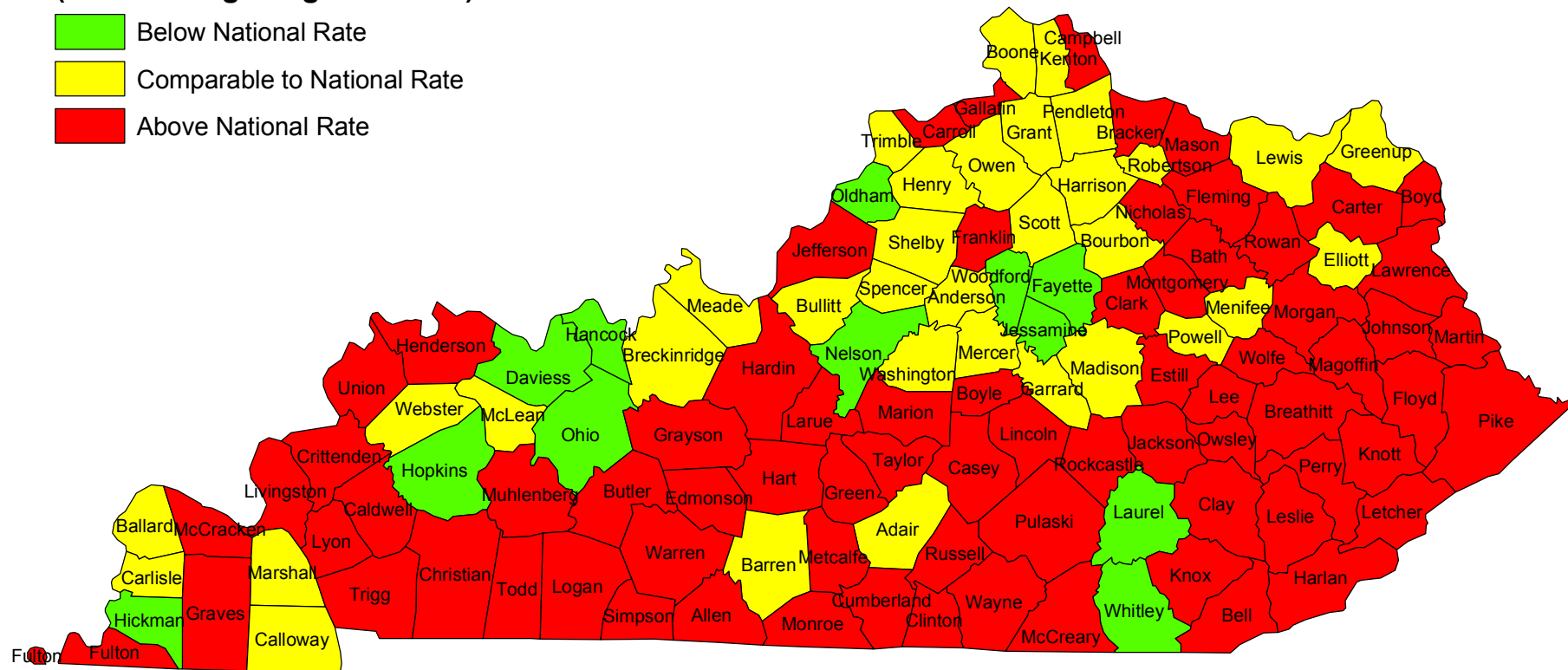

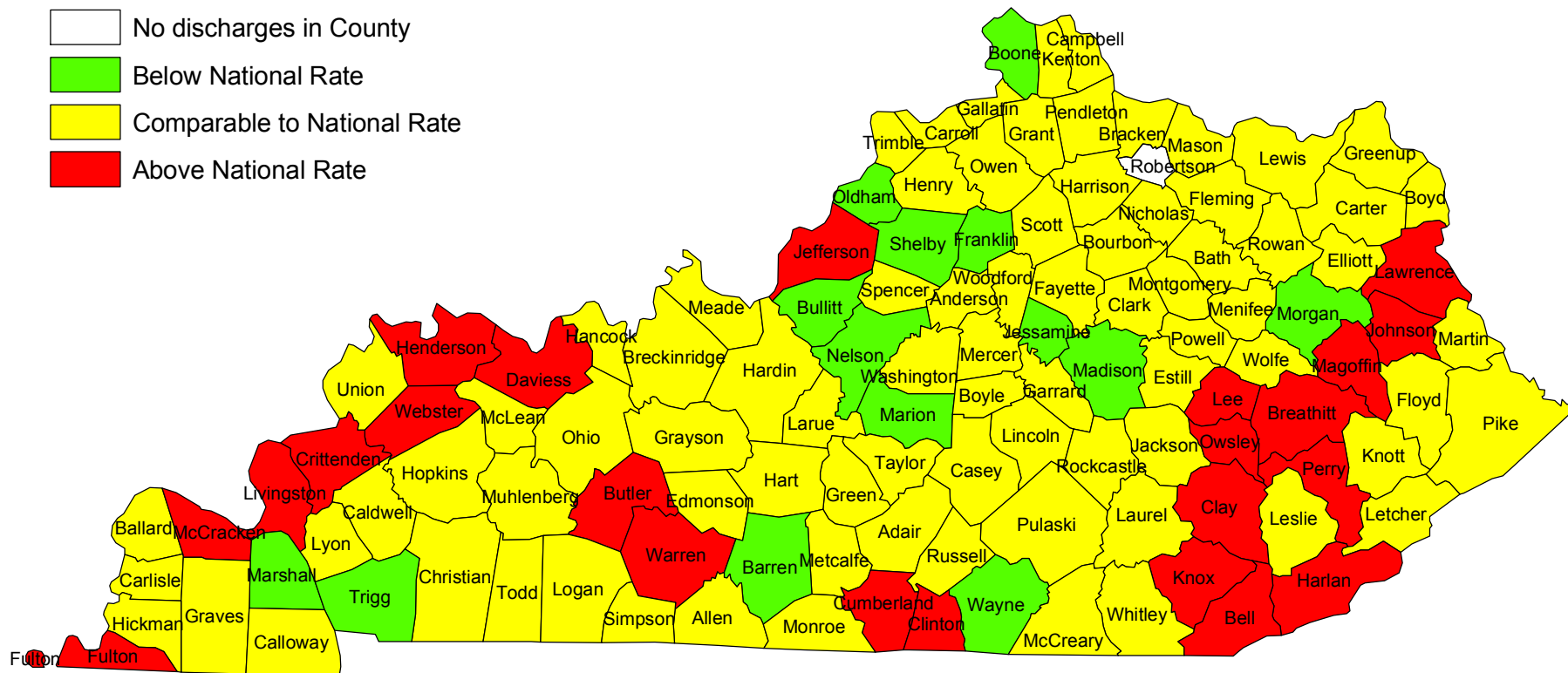

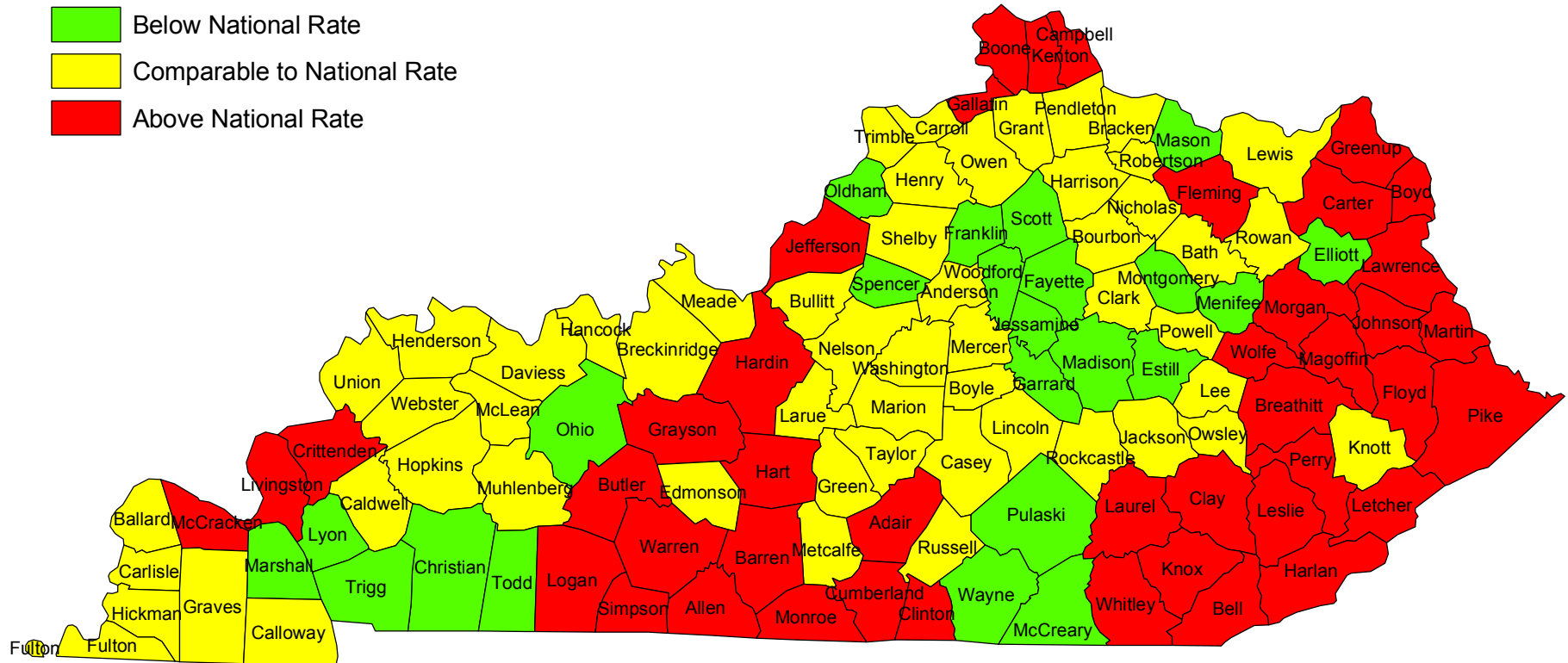

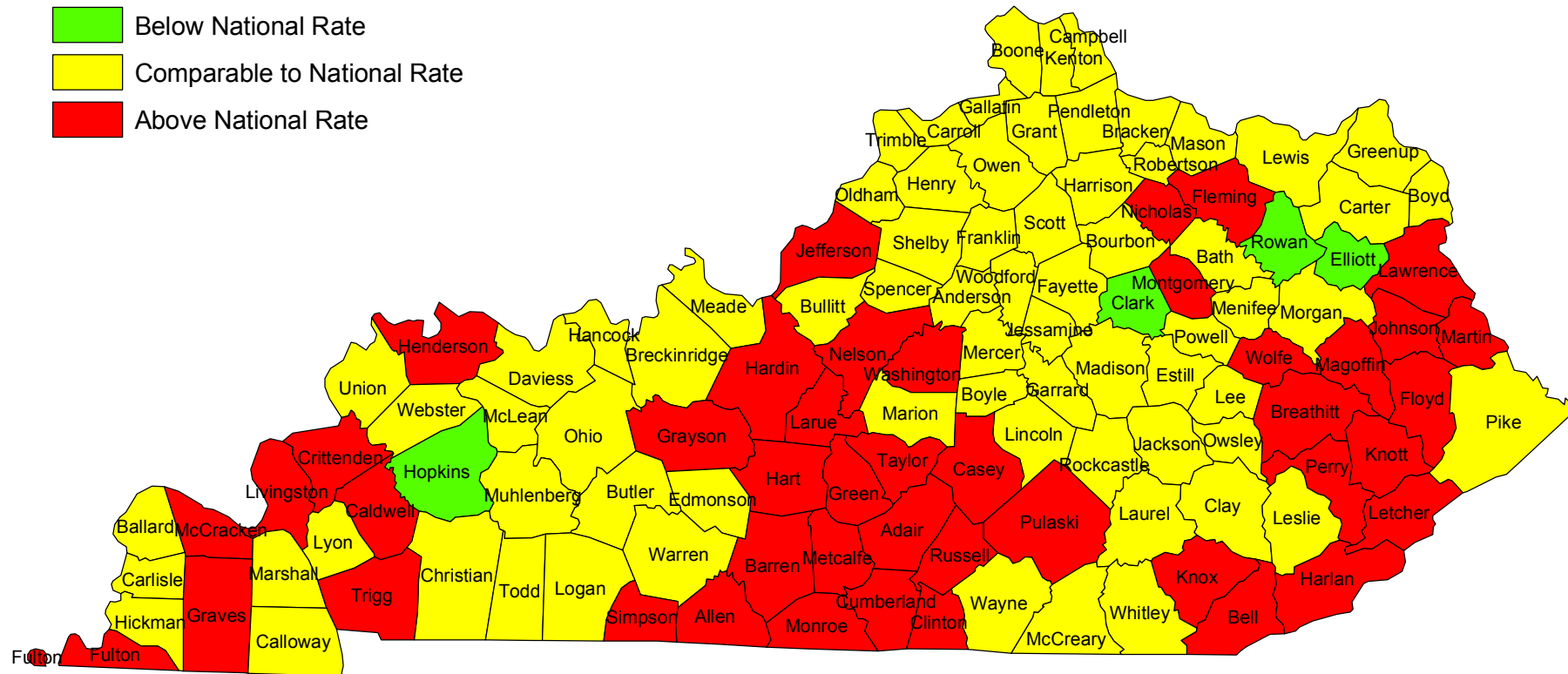

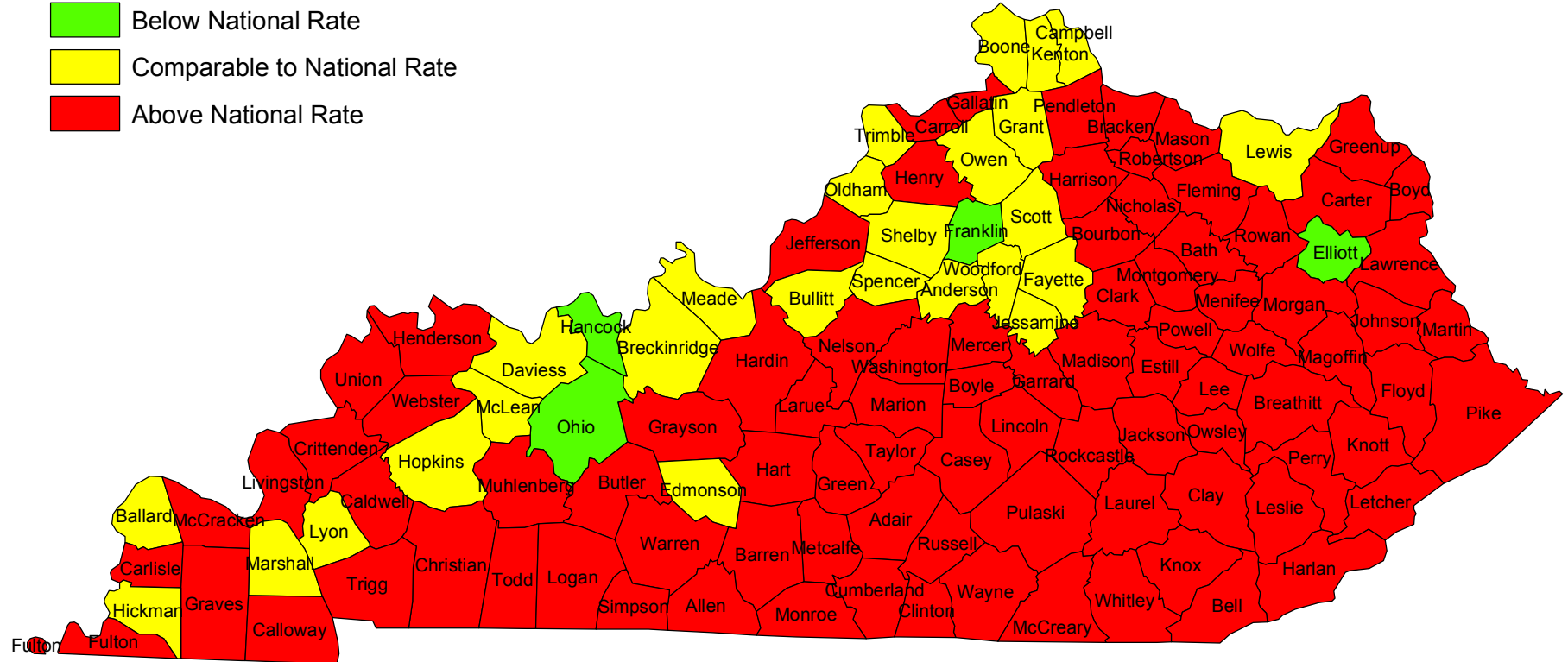

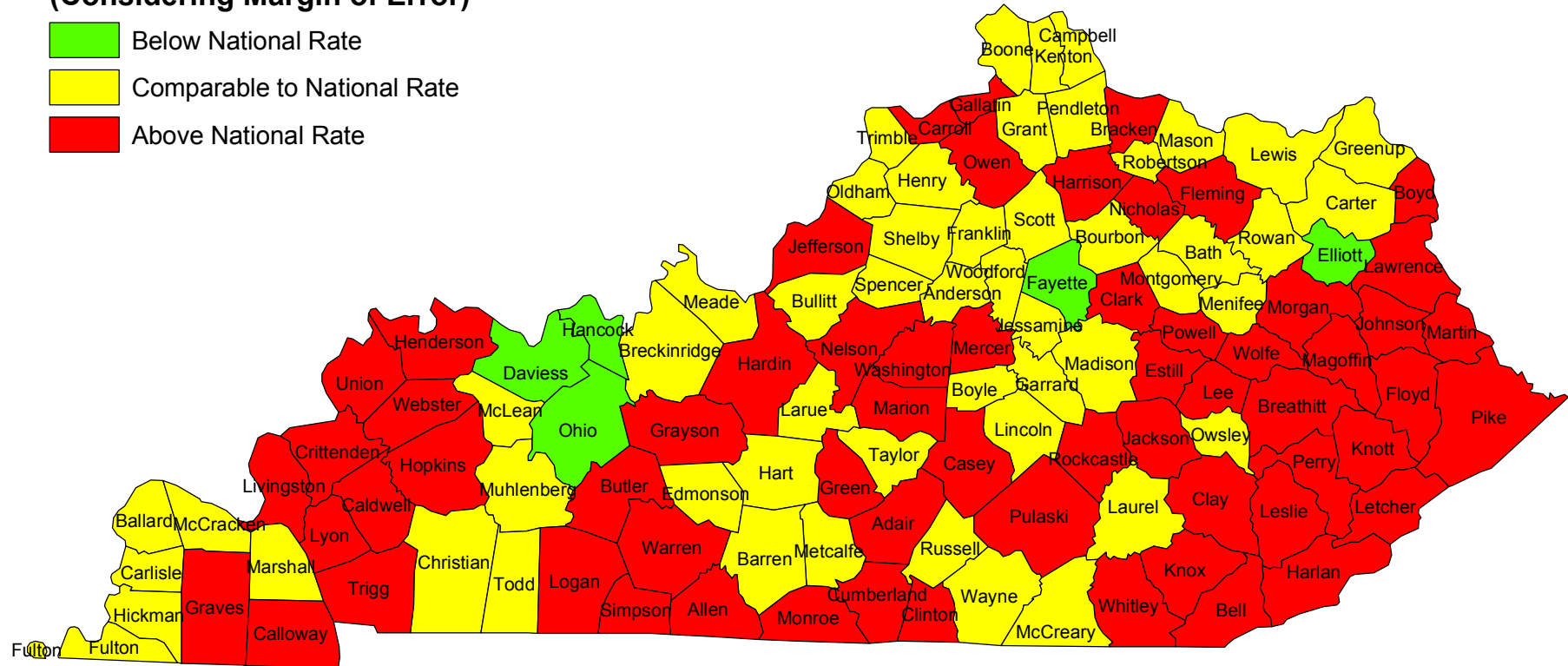

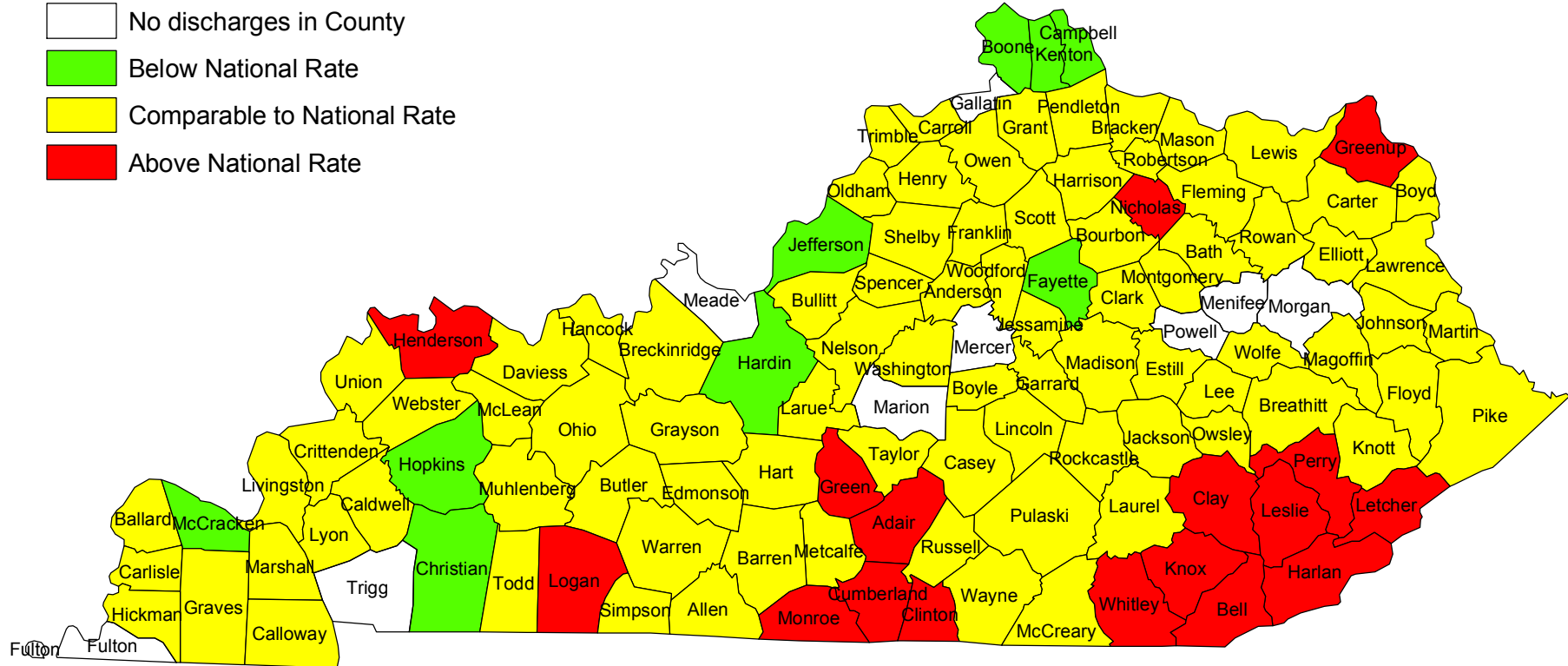

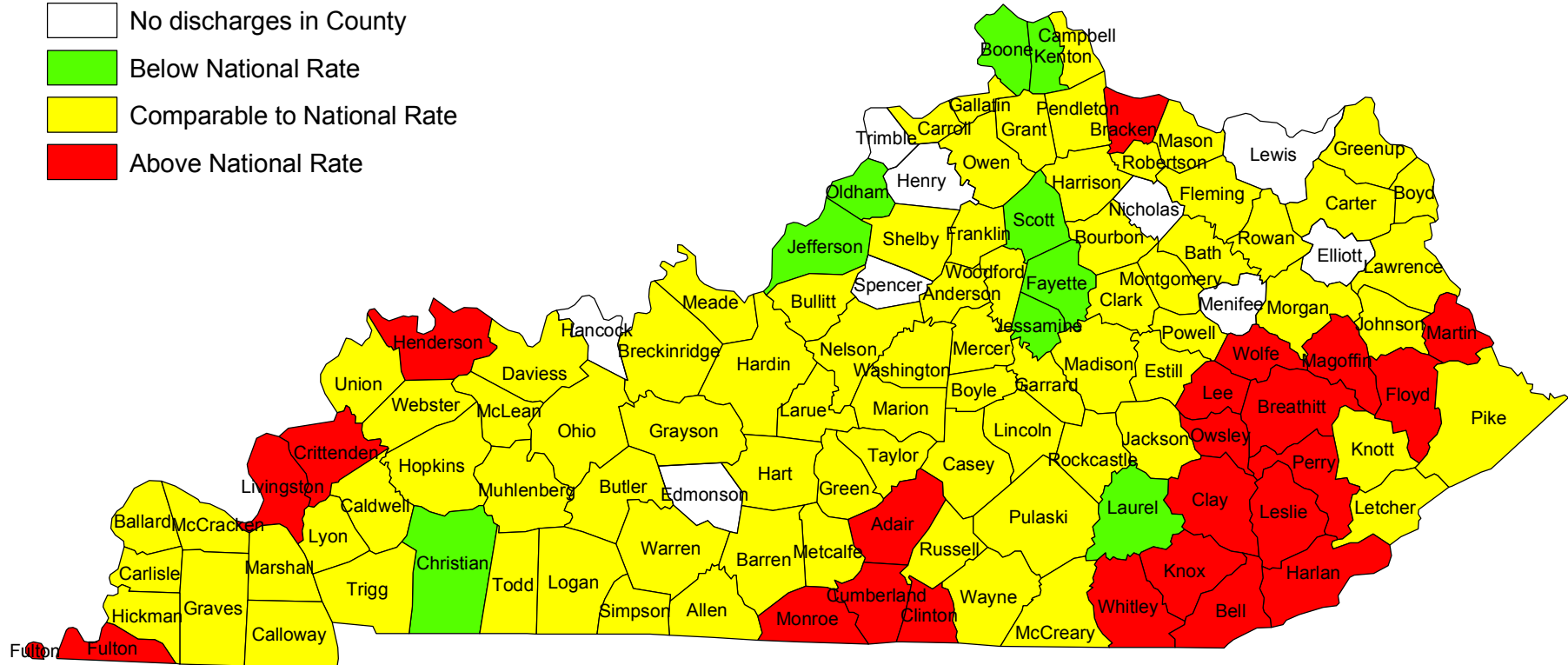

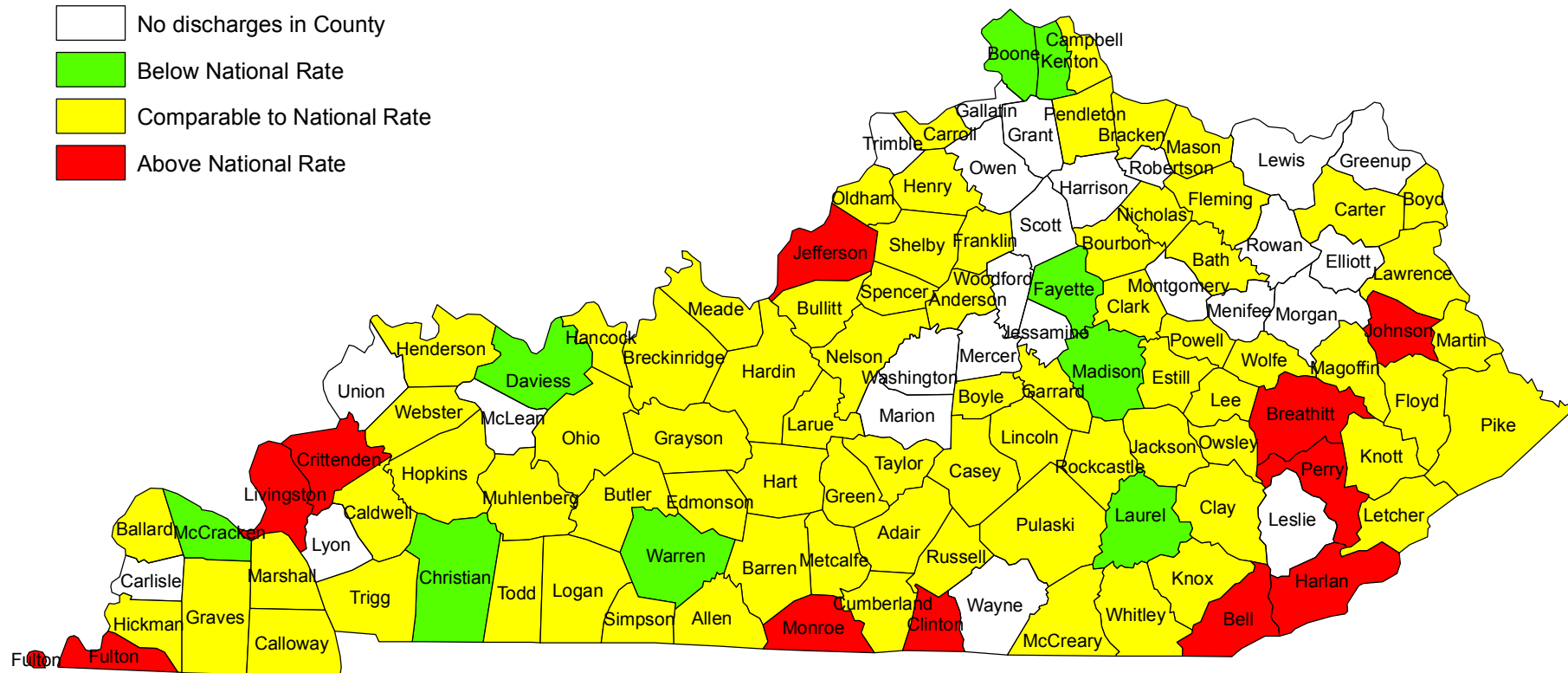

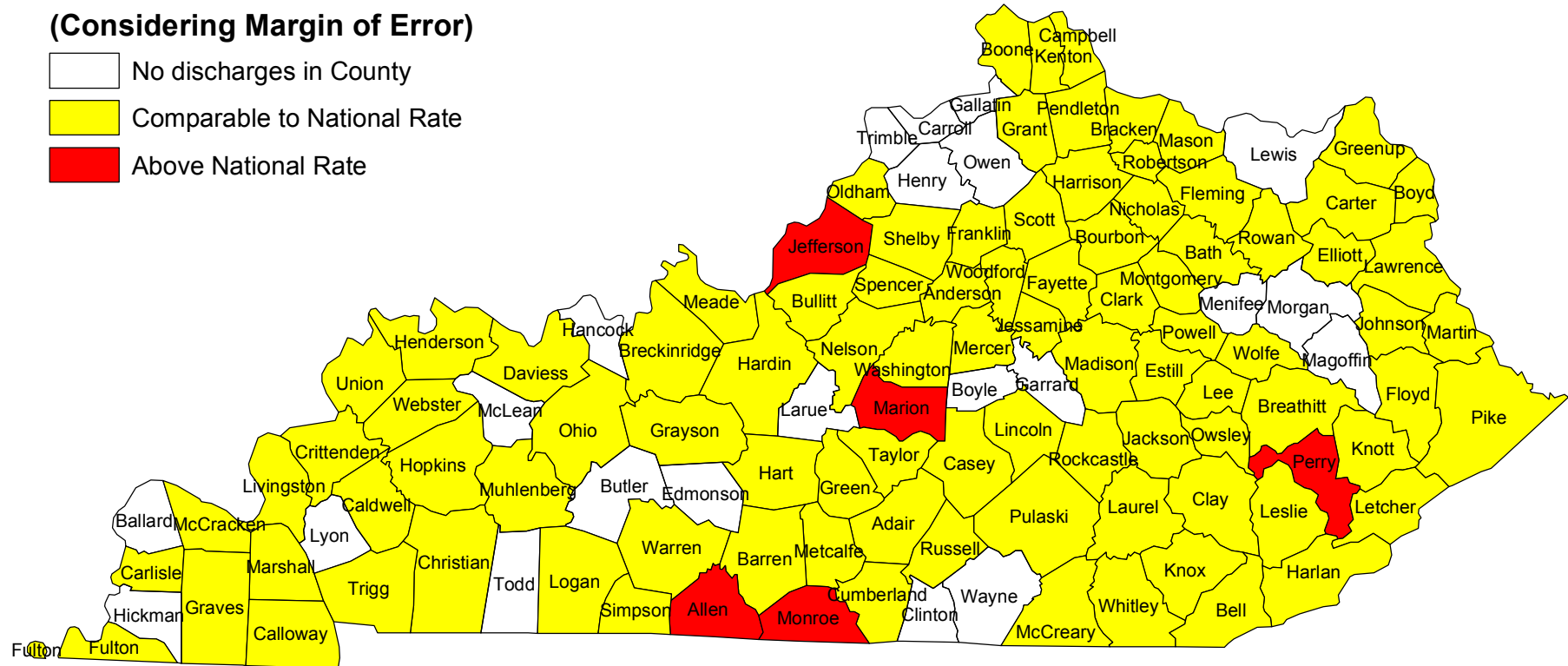

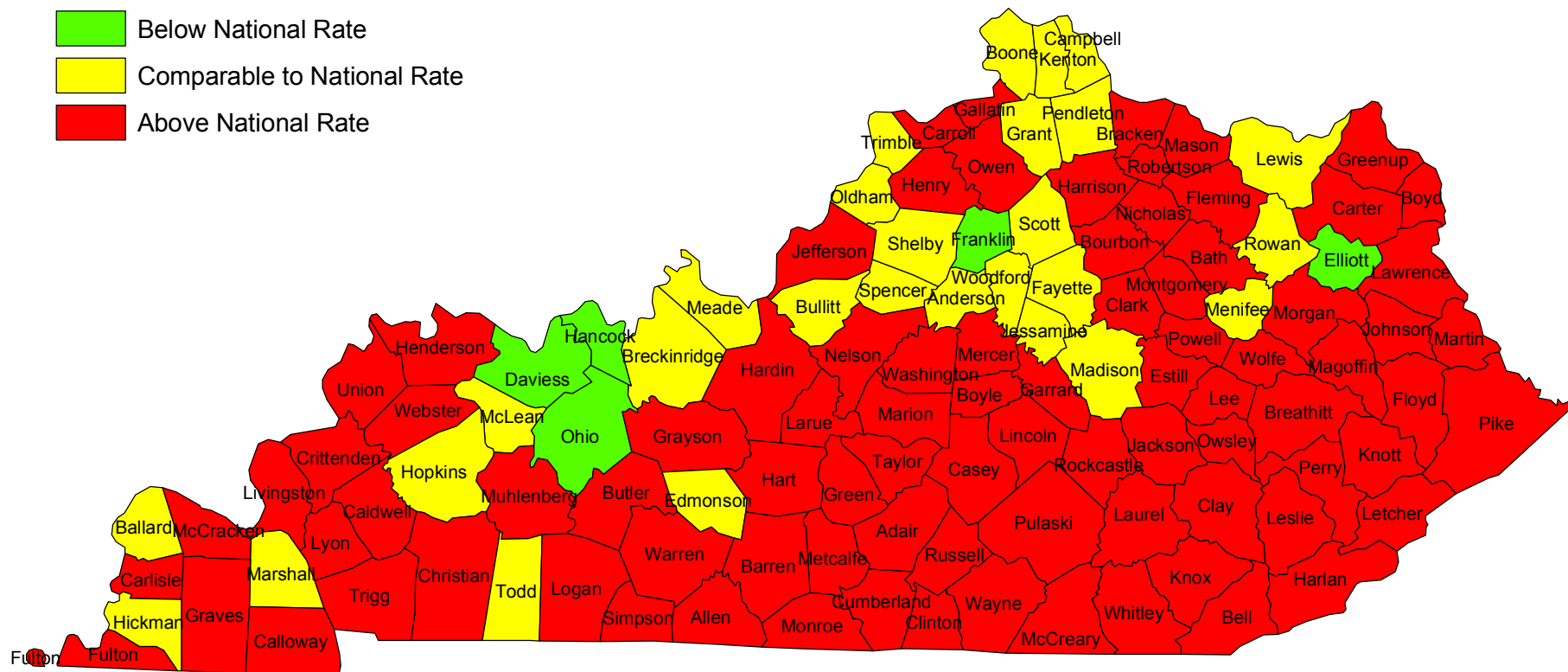

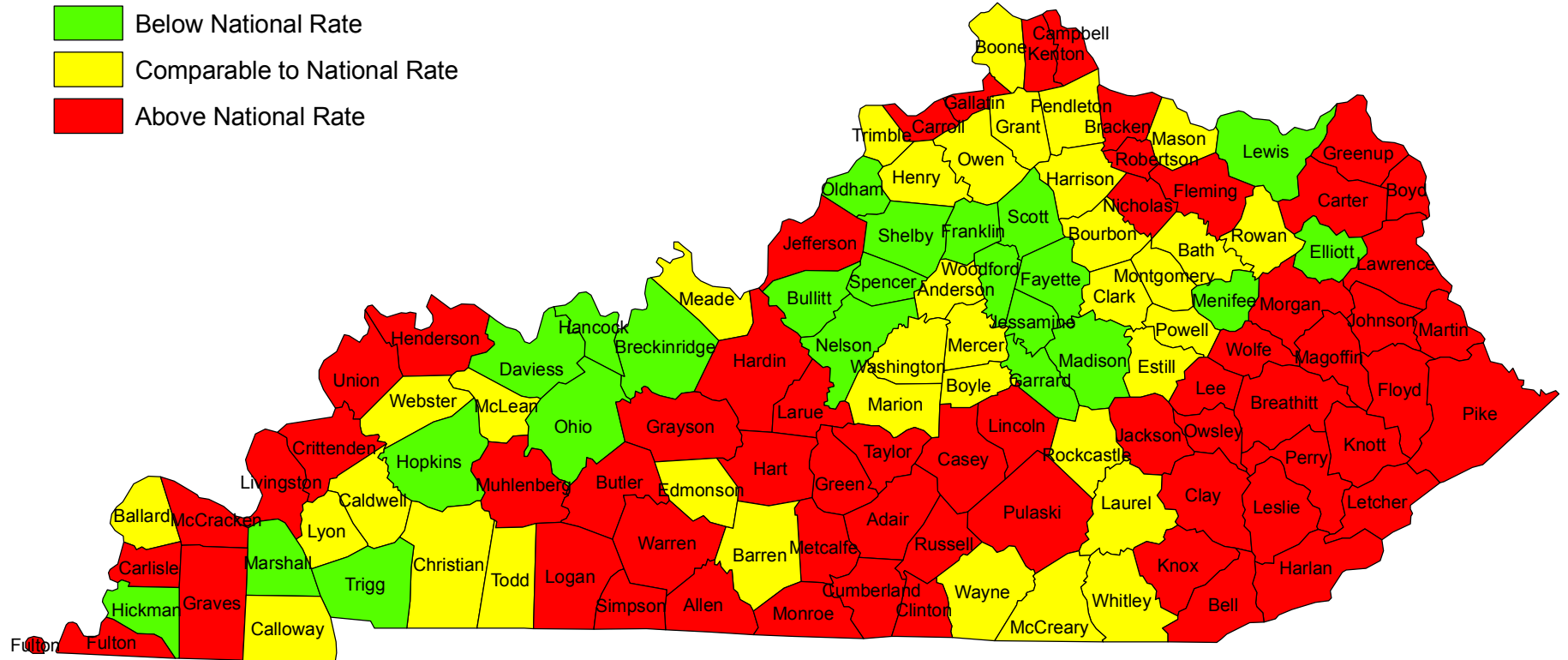

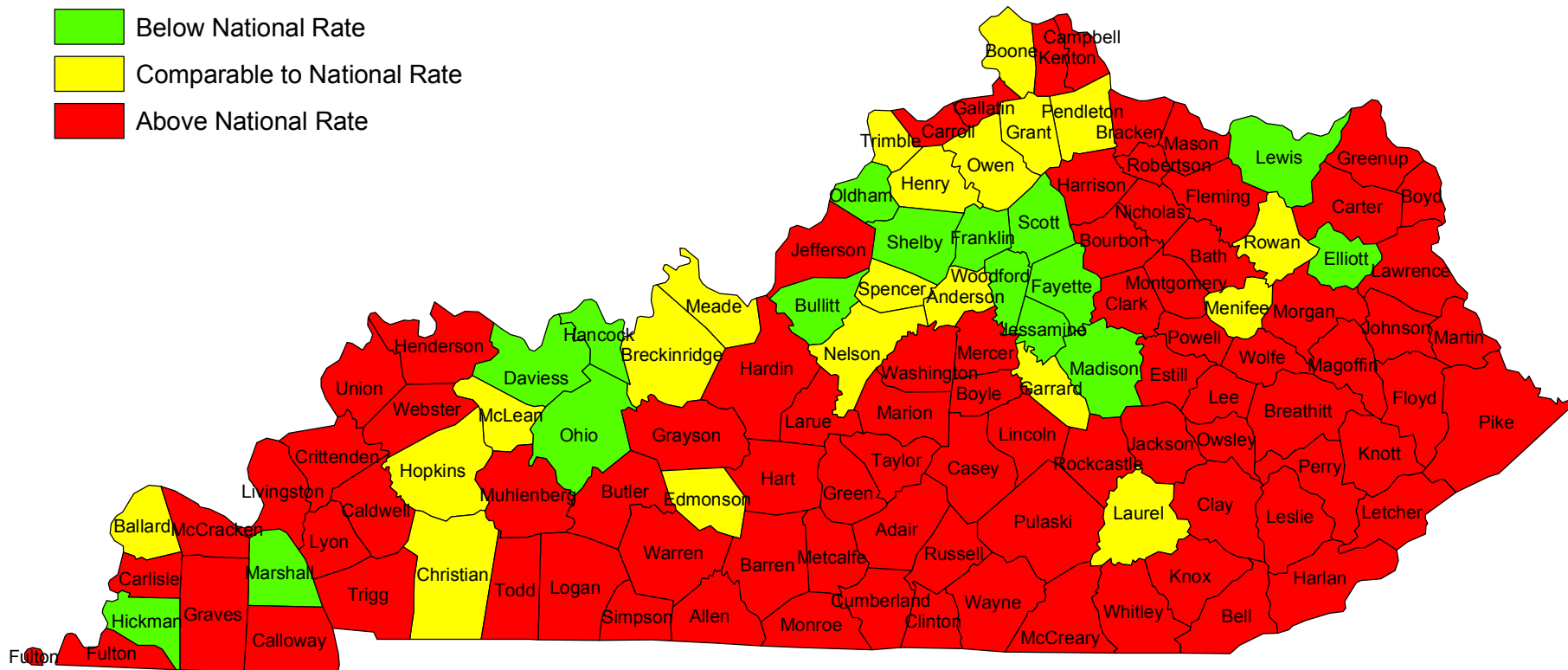
